MIX SRL UNIPERSONALE, DATA CONTROLLER, WISHES TO INFORM YOU OF HOW IT WILL PROCESS YOUR DATA PURSUANT TO ARTICLE 13 OF THE EUROPEAN REGULATION 2016/679

PURPOSE OF THE PROCESSING AND LEGAL BASIS

THE DATA COLLECTED (NAME AND SURNAME, E-MAIL ADDRESS, RESIDENCE, TELEPHONE NUMBER AND CURRICULAR DATA) WILL BE PROCESSED EXCLUSIVELY TO CARRY OUT A PERSONNEL SELECTION ACTIVITY. THE PROCESSING OF COMMON DATA RESPONDS TO THE EXECUTION OF PRE-CONTRACTUAL MEASURES (ART.6 PAR.1 LETTER B OF THE GDPR), WHILE THE TREATMENT OF PARTICULAR CATEGORIES OF DATA SUCH AS HEALTH DATA POSSIBLY PRESENT IN THE CURRICULUM HAS THE LEGAL BASIS AS THE YOUR EXPLICIT CONSENT (ART.9 PARAGRAPH 2 LETTER A OF THE GDPR). THE PROVISION OF DATA IS NECESSARY IN ORDER TO PARTICIPATE IN THE SELECTION ACTIVITY BY THE OWNER AND THEIR FAILURE TO PROVIDE IT MAKES IT IMPOSSIBLE FOR THE OWNER TO SELECT HIS APPLICATION.

TRANSFER OF DATA TO THIRD COUNTRIES

NO TRANSFER OF YOUR DATA IS FORESEEN IN NON-EU COUNTRIES, WITH THE EXCEPTION OF CANDIDATES WHO MAY BE INTERESTED IN THE GROUP'S NON-EU BRANCHES. IN SUCH CASES, THE OWNER MAY TRANSFER THE DATA TO NON-EU BRANCHES ONLY FOLLOWING HIS EXPLICIT CONSENT (ART.49 PAR. 1 LETTER A OF THE GDPR).

DATA RETENTION PERIOD

THE DATA WILL BE KEPT FOR THE TIME NECESSARY TO COMPLETELY PROCESS YOUR REQUEST AND IN ANY CASE DELETED WITHIN 24 MONTHS FROM THE DATE OF RECEIPT (UNLESS THE SELECTION, IN THAT PERIOD, DOES NOT LEAD TO THE ESTABLISHMENT OF A CONTRACTUAL RELATIONSHIP)

METHOD OF TREATMENT

THE TREATMENT WILL TAKE PLACE BOTH WITH THE USE OF PAPER SUPPORT AND WITH THE AID OF ELECTRONIC COMPUTER TOOLS. THE DATA CONTROLLER, THROUGH THE TREATMENT AND STORAGE SYSTEMS OF THE ARCHIVES, ENSURES AND GUARANTEES THAT THE DATA WILL BE PROCESSED ACCORDING TO WHAT IS ESTABLISHED BY LAW.

RECIPIENTS OF THE DATA

THE DATA WILL BE MADE AVAILABLE TO INTERNAL STAFF, AUTHORIZED FOR THE TREATMENT AIMED AT STAFF MANAGEMENT AS WELL AS IT STAFF, GROUP BRANCHES INTERESTED IN SELECTION ACTIVITIES AND IT COMPANIES, APPOINTED RESPONSIBLE FOR THE SITE'S TECHNICAL ASSISTANCE. THE DATA WILL NOT BE DISSEMINATED.

RIGHTS OF THE INTERESTED PARTY

PURSUANT TO CHAPTER III OF THE GDPR, THE INTERESTED PARTY HAS ALWAYS THE RIGHT TO REQUEST FROM THE DATA CONTROLLER ACCESS TO YOUR DATA, THE CORRECTION OR CANCELLATION OF THE SAME, THE LIMITATION OF THE TREATMENT OR THE POSSIBILITY OF OPPOSING THE TREATMENT, TO REQUEST THE PORTABILITY OF THE DATA, TO REVOKE (WHERE RELEASED) THE CONSENT TO THE PROCESSING BY ASSERTING THESE AND OTHER RIGHTS PROVIDED BY THE GDPR THROUGH SIMPLE COMMUNICATION TO THE DATA CONTROLLER. FINALLY, THE INTERESTED PARTY HAS THE RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY IF HE BELIEVES THAT THE PROCESSING THAT CONCERNS HIM VIOLATES THE LEGISLATION APPLICABLE TO THE PROTECTION OF HIS DATA.
