### **INFORMATION ON THE PROCESSING OF PERSONAL DATA OF USERS WHO CONSULT THE SITE PURSUANT TO ART.13 OF THE EUROPEAN REGULATION 2016/679**

#### **PREMISE**

**THIS SECTION DESCRIBES THE SITE MANAGEMENT METHODS ADOPTED BY MIX SRL UNIPERSONALE IN RELATION TO THE PROCESSING OF PERSONAL DATA OF USERS WHO ACCESS AND CONSULT IT. #### **PLACE OF DATA PROCESSING AND COMMUNICATION AND DISCLOSURE**

**THE FOLLOWING SITE IS PHYSICALLY "HOSTED" IN THE NETHERLANDS AT THE SITEGROUND COMPANY, THE DATA IS COLLECTED AT THE HEADQUARTERS OF MIX SRL UNIPERSONALE WHILE THE TECHNICAL ASSISTANCE IS TAKEN CARE OF BY THE COMPANY WEBIT, APPOINTED EXTERNAL MANAGER FOR CONSULTANCY AND TECHNICAL ASSISTANCE. TO THE WEBSITE. USER DATA WILL BE PROCESSED INTERNALLY BY AUTHORIZED ENTITIES OF THE IT AND COMMERCIAL OFFICE AND EXTERNALLY BY THE GROUP'S FOREIGN BRANCHES. #### **TYPES OF DATA PROCESSED**

##### **• NAVIGATION DATA**

**DURING THEIR NORMAL OPERATION, THE IT SYSTEMS AND SOFTWARE PROCEDURES USED TO OPERATE THIS WEBSITE ACQUIRE SOME PERSONAL DATA WHOSE TRANSMISSION IS IMPLICIT IN THE USE OF INTERNET COMMUNICATION PROTOCOLS. THIS IS INFORMATION THAT IS NOT COLLECTED TO BE ASSOCIATED WITH IDENTIFIED INTERESTED PARTIES, BUT WHICH BY ITS VERY NATURE COULD, THROUGH PROCESSING AND ASSOCIATION WITH DATA HELD BY THIRD PARTIES, ALLOW USERS TO BE IDENTIFIED. THIS CATEGORY OF DATA INCLUDES THE IP ADDRESSES OR DOMAIN NAMES OF THE COMPUTERS USED BY USERS WHO CONNECT TO THE SITE, THE ADDRESSES IN URI (UNIFORM RESOURCE IDENTIFIER) NOTATION OF THE REQUESTED RESOURCES, THE TIME OF THE REQUEST, THE METHOD USED IN SUBMITTING THE REQUEST TO THE SERVER, THE SIZE OF THE FILE OBTAINED IN RESPONSE, THE NUMERIC CODE INDICATING THE STATUS OF THE RESPONSE GIVEN BY THE SERVER (SUCCESSFUL, ERROR, ETC.) AND OTHER PARAMETERS RELATING TO THE OPERATING SYSTEM AND THE USER'S COMPUTER ENVIRONMENT. THESE DATA ARE USED FOR THE SOLE PURPOSE OF OBTAINING ANONYMOUS STATISTICAL INFORMATION ON THE USE OF THE SITE AND TO CHECK ITS CORRECT FUNCTIONING AND ARE DELETED IMMEDIATELY AFTER PROCESSING. THE DATA COULD BE USED TO ASCERTAIN RESPONSIBILITY IN CASE OF HYPOTHETICAL COMPUTER CRIMES AGAINST THE SITE.**

##### **• DATA PROVIDED VOLUNTARILY BY THE USER**

**THE USER HAS THE OPPORTUNITY TO INTERACT WITH THE SITE BY PROVIDING THEIR DATA IN THE "CONTACTS", "REQUEST FOR AN OFFER", "CUSTOMER SATISFACTION SURVEY", "WORK WITH US" PAGES. USERS ARE INVITED NOT TO SEND SENSITIVE DATA IN THEIR COMMUNICATIONS AS DATA SUITABLE TO REVEAL RACIAL AND ETHNIC ORIGIN, POLITICAL OPINIONS, RELIGIOUS OR PHILOSOPHICAL BELIEFS, TRADE UNION MEMBERSHIP, HEALTH AND SEXUAL LIFE DATA, AS WELL AS GENETIC AND BIOMETRIC DATA BEYOND TO IDENTIFICATION DATA OF THIRD PARTIES (IN THIS CASE IT IS BETTER TO USE INVENTED NAMES).**
