## PURPOSE OF THE PROCESSING AND LEGAL BASIS

FOLLOWING THE CREATION OF A PROFILE BY E-MAIL, USERNAME AND PASSWORD, THE DATA SUBSEQUENTLY COLLECTED (COMPANY NAME, COUNTRY, TELEPHONE AS MANDATORY AND COMPANY ACTIVITIES, REFERENCE PERSON, QUALIFICATION, LOCATION, ADDRESS, FAX, MOBILE PHONE, SITE WEB AS OPTIONAL) WILL BE TREATED EXCLUSIVELY TO PRESENT OUR BEST OFFER BASED ON YOUR REQUESTS.
